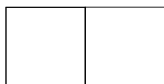

Standard 1

Summary

Comply with legal requirements for publication, presentation and notification, including PPD tables.

CPTPP notification

Some legislation has additional notification requirements under the CPTPP

Presentation to Parliament

Hard copies as well as digital files are required for presentation to Parliament

Website publishing

Secondary legislation must be available on a public website, with additional requirements

Gazette notification

Minimum metadata must be submitted for publication in the Gazette

Standard 2

Summary

Publish all secondary legislation in full on your website and keep it there.

Website publishing

Secondary legislation you administer needs to be on your website.

Publish in full

Users need to be able to view the full secondary legislation, not just a link to it.

Maintain old versions indefinitely

Users need to be able to compare new versions with old versions.

Gazette links are insufficient

Web publication is important even if legislation only requires Gazette notification

Publish to website with pinpoint links to document elements, including bullet points, paragraphs and cells in tables



Publish to multiple locations at once using DocRef APIs



Publish multiple document versions with textual comparisons, status indicators and change logs



Standard 3

Summary

Changes to the law over time must be clear to users.

Unofficial consolidations

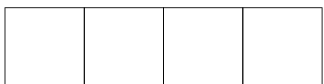
If consolidations of multiple amendments are published, it needs to be clear whether these are official.

Transparent amendments

Where the law has changed, it should be clear what those changes are, and when they took effect.

Standard 4

Summary

Basic minimum information is necessary to understand who made the document under what authority

Title

What does the legislation cover, and in what context?

Empowering provision

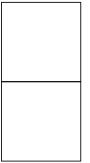
Which Act and provision empowered you to create it?

Administering agency

Which agency administers the legislation if any scrutiny or oversight is required?

Standard 5

Summary

Published in HTML and compliant with web accessibility standards.

Accessible

Compliant with WCAG and NZ Government web accessibility standards, with HTML versions available.

Digital and re-usable

The standards recognise the benefits of publishing secondary legislation in re-usable formats to enable innovation.

Standard 6

Summary

Legislation should be easy to find, navigate and use, including across multiple instruments.

Legislation web specifications

If consolidations of multiple amendments are published, it needs to be clear whether these are official.

Navigation between documents

Where the law has changed, it should be clear what those changes are, and when they took effect.
